Furthermore, the client requests a socialized environment for their dog while under the care of MFP.

\_\_\_\_\_ The client agrees to assume all liabilities and responsibilities, financial or otherwise, for the behavior and health of the client's dog. The client agrees to hold MFP harmless from any claims, actions or demands against MFP arising during the pick-up, transport, drop-off, and stay at MFP's facilities.

\_\_\_\_\_ The client authorizes MFP to do whatever they deem necessary for the safety, health and well being of the client's dog while under the care of MFP.

\_\_\_\_\_ The client acknowledges that MFP will assume full ownership of any dog left in its care over 10 days without being claimed by said client. MFP has the right to do whatever it deems proper and necessary for the well being of the dog.

\_\_\_\_\_ The client will assume all legal fees due to failure to pay balance in full. Any balance left unpaid over 30 days without written arrangement will be handled by a collection agency and all discounts forfeited.



The Client may terminate this agreement at any time upon providing at least 30 days' written notice to the Vendor. The Vendor may terminate this agreement at any time upon providing at least 30 days' written notice to the Client.
